If you are interested in submitting your paper for Transcultural Management Review, please send us your manuscripts. Please refer to following information in details.

**1. Topics**

We are interested in any and all articles, so long as they address issues relating to cross-cultural management.

Topics can include, but are not limited to:

- 1) Global Business and Transcultural Management
- 2) Global Strategy/Organization and Transcultural Management
- 3) Transcultural Management and International Human Resource Management (IHRM)
- 4) Diversity Management
- 5) Knowledge Management and Transcultural Management
- 6) Case Study of Transcultural Management
- 7) Global Leadership
- 8) Global Talent Management
- 9) Corporate Governance
- 10) Others

**2. Types of Manuscripts**

**Research Article**

Research article making strong contributions to the research area of transcultural management should be no more than 6,000 words. If reviewers assess a manuscript makes a limited contribution, we may accept a manuscript as a research note instead of an article with advance notice to author(s).

**Research Note**

Compared to research articles, research notes are not necessary to have strong theoretical implications or/and rigorous data analysis. Research note should be no more than 6,000 words.

### **Case Study**

Case studies are different from articles and research notes in that the contribution either describes real business practices or more limited in its contributions. Case studies should be under 3,500 words.

### **Perspective**

Perspectives should have implications for academic studies, educational fields, and business practices regarding the subjects of history, policy, and current affairs. They do not need to have strong theoretical implications and rigorous data analysis. They should be under 6,000 words.

For any of the types of manuscript, a single figure, table, or appendix should be counted as 150 words. The word count includes everything: abstract, text, endnotes, references, tables, figures, and appendices.

### **3. How to Submit**

2. Fill in the first author's name, affiliation and e-mail address, and click submit.
3. Please upload your manuscript according to instructions.
  - ※ You don't need to send us your printed manuscripts.
  - ※ We don't send you an e-mail regarding acceptance.

### **4. Deadline for submission**

The submission deadline for Issue No.20 is 30th June 2023. Please note that the document failing to meet the deadline will not be accepted for any reason.

### **5. Requirements for submission**

- ☆ Your research should contribute to our society and your manuscript must be original and unpublished works.
- ☆ When you submit your manuscript, you or your co-author(s) should be a member of Transcultural Management Society. If you or your co-author(s) are currently applying for our membership, our editorial members and committee will decide whether we will be able to accept your manuscript.

### **6. Notification of Acceptance**

All manuscripts will undergo a double-blind review process. Our editorial members and reviewers will decide whether your manuscript will be suitable for our journal. And we will contact you around the end of September.

#### **7. Submission of manuscript after Acceptance Notice**

After your manuscript is reviewed, we will contact you to inform whether your manuscript is accepted or not. Depending on reviewers' comments, you may need to revise and resubmit your manuscript in order to respond reviewers. In that case, you will have to resubmit your manuscript by the end of October.

Please note that the document failing to meet the deadline will not be accepted for any reason.
